**Agenda:-**

1. To Peruse the Notice furnished by Executive Engineer, Public Works Department, Roads Section, Kozhikode-20, directing to deviate traffic through **Panampilavu-Thottumukkam-Edakkattuparamb-Vettillappara-Vadakkumuri-Areacode**, and through **Edakkattuparamba-Thottumukkam-Valilappuzha-Areacode** since, transportation through 'Thottumukkam-Kuzhikkinippara Palam' has been blocked due to the re-construction Work.
2. To consider the application for Temporary Permit so as to deviate service from Thottumukkam to Vadakkumuri Via Edakkattuparamba, Vettillappara u/s 87(1)c vehicles, since transportation through Thottumukkam to Kizhakkinippara Palam had been banned due to re-construction of 'Thottumukkam - Kizhakkinippara Palam.'

**Decision:**

1. This is an application to decide on the nature of action to be taken to meet the urgent travelling needs of general public especially the stage carriage operation due to the route diversion followed by the reconstruction of Kuzhinakkippara bridge.
2. Executive Engineer, Public Works Department (Roads), Kozhikkode has banned the stage carriage operation through the route Thottumukkam - Kuzhinakkippara due to the re-construction of Kuzhinakkippara Bridge. He has also directed to divert the service of all vehicles passing through this bridge to
  - (1) Panampilavu - Thottumukkam-Edakkattuparambu-Vettillappara-Vadakkumuri-Areacode. OR
  - (2) Edakkattuparamba - Thottumukkam-Valillappuzha-Areacode
3. Applications from the permit holders for temporary permits u/s 87(1) c with respect to the stage carriage

a) KL 55 A 2158 operating with the strength of Substitute Temporary permit in place of the stage carriage KL 13 H 9843 on the route Thottumukkam – Areacode via Kuzhinakkippara. He has also submitted that the route bus having regular permit on the above route KL 13 H 9843 is off the road due to completion of 15 years.

b) KL 11 X 2253 operating on the route Edakkattuparamba – Areacode via Thottumukkam, Kuzhinakkippara

c) KL 57 H 6278 operating on the route Edakkattuparamba – Areacode touching Koombara,

4. Motor Vehicle Inspector, Malappuram has ascertained the need for diversion of vehicular service, especially stage carriage service through the route recommended by the Executive Engineer

5. Examined the matter as per the provisions contained in Section 115 of Motor Vehicles Act 1988 and Rule 339 of Kerala Motor Vehicles Rules, 1989. As per Rule 339, the direction issued by the Executive Engineer, Public Works Department is legal and as per law. Also, we are of the opinion that the request of en-route operators to issue temporary permits u/s 87(1) c is not maintainable and hence rejected.

6. However for continued operation of stage carriage service and for the benefit of travelling public the direction issued by the Executive Engineer, PWD is approved and directed all stage carriages operating with live regular permits to operate through either of the varied route as specified in the letter of Executive Engineer. Provided that:

(1) this deviation is purely temporary in nature and it is only up to the completion of the reconstruction of Kuzhinakkippara bridge.

(2) the operation of deviated permits should not restrict or hinder the operation of other stage carriages regularly servicing through the original route.

Also, the Secretary, RTA will amicably settle the issues, if any arises due to this temporary deviation of stage carriage service.
