**NOTICE FOR TIMING CONFERENCE**

The list of vehicles included for timing conference (after incorporating the requested changes on draft notice published on 20/05/2015 up to **16/06/2015** is published herewith. Concerned operators, permit applicants, petitioners and respondents in the WP(C)/MVAA/MVARP or their authorized representatives shall treat this as their individual timing conference intimation and to attend the conference without fail.

Only en-route operators or their authorized representatives will be allowed to attend the conference. The persons attending the conference are directed to produce relevant documents such as permit and timing schedules in original and authorization for verification at the time of conference. Production of original current records will be a pre requisite for conducting the timing conference. More than one person could not be allowed to represent one vehicle.

Conference usually begins at **10.00 a.m.** if not mentioned otherwise.

Venue: Collectorate conference Hall, Malappuram or any other hall suggested by the District Collector.
